


- SCCAP works closely with over 25 faith based organizations, 75+ private service providers & public county offices within our 8 county region

5,952 Households Served in MV for 2019





- ❖ ***1,221 Households requested housing assistance***
- ❖ ***893 Households were identified homeless/or at imminent risk***
- ❖ ***261 Households literally homeless obtained permanent housing***
- ❖ ***923 Families were diverted from homelessness***

USDA/RD Self Helping Housing

- To date: 70 homes completed 6 under construction
- Average home value is \$210,00 after completion
- 44 Homes in Kimberly/ 26 Homes in Filer
- Broke ground Group 12 ~ Filer June 26th, 2019
- Move in March 27, 2020/ No Key Ceremony/ COVID-19

w/ 414,089 Lbs. food distributed at a value over \$500,750***

11 Food Pantries & 2 Soup Kitchens throughout MV

***Annually SCCAP only receives approx.
\$33,000 of USDA Federal Funding (increased in 2019)
to operate our food distribution program***

***Program cost SCCAP over \$72,000 annually to operate
requiring SCCAP to seek non federal donations to cover
difference in Operations, Shipping, Storage & Distribution.***
